Your letter of June 23, is received.

If your men wish to put in the small bridges you mention, as a contribution, it will be 0.K. We do not have any steel culvert.

The county expense should be paid by the ranger at Big Timber since he has taken over that area July 1. And if he wishes to pay you for the bridge planks, he can do that, or make any other arrangements. I think something can be done whenever we get straightened out on this consolidation business and we get our new allotments. I think you should see Ranger Roemer, since he is in charge of your territory.
